2024 Spruce Meadows Name the Foal presented by TELUS Promotion

CONTEST RULES (the "Rules")

PROMOTION PERIOD:

1. The Spruce Meadows ("Spruce Meadows") 'Name the Foal presented by TELUS' promotion (the "Promotion") starts at 9:00 am, MT, Thursday, June 3, 2024 and ends at 23:59 pm MT, Friday August 2, 2024 (the "Promotion Period").

In the event that a selected name has been entered by more than one person, the winner shall be randomly selected from those entries submitted for the selected name. Spruce Meadows shall advise selected entrants on or before Friday, August 16, 2024 that they have been selected.

Each selected entrant will be contacted by email and will be required to correctly answer, unaided, a time-limited, mathematical skill-testing question, confirm their eligibility and otherwise comply with these Rules before being declared the winner.
