- **Extra Stalls:** The number must be the same for the all weeks, and must be the same level as the horse stall.
- If stabling with a group, the group must request the same level of stabling.
- You must inform the Tournament Office AT LEAST 72 hours before your arrival. The gates will NOT be open if you are not expected. There is a \$250 fine if your horse is found in an unauthorized stall at any time.
- If you do not select stabling for the Off-Week, and are returning for the 2nd Tour, your stalls will not be in the same location and set ups must be fully dismantled.
