If payment is not received by the closing date, the EC horse will be assessed a late fee of \$600 and is subject to the approval of the Organizing Committee. \$1000/week will be taken in late April, and the balance of the account will be processed in May. A \$950 no-show fee per week (plus any extra or off week stalls and pre-ordered feed) will be charged for horses entered in the FEI entry system that do not compete, or are withdrawn after the definite date. Horses withdrawn out of the FEI entry system after the definite date are responsible for both the late withdraw fee IN ADDITION to any EC competition/non-competing fees.
